#### MOTION REQUESTED

A) Approve Piggyback No. PB220535KLB – PB230550KLB Information Technology Cyber Security Staff Augmentation to utilize pricing on the Department of Management Services – Florida State Contract No. 80101507-21-STC-ITSA for Information Technology Cyber Security Staff Augmentation with IT Staffing and Consulting, Inc. d.b.a ISC, on an as needed basis, through the contract expiration date of September 30, 2024 and any renewals or extensions approved by Department of Management Services, as approved in the departments' annual adopted budget, in the amount of \$1,208,904.00 annually.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contract and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s).

#### II. ITEM SUMMARY

Approves a piggyback purchase to renew the contract for cybersecurity staff augmentation and services for one year in the amount of \$1,208,904.00. This contract continues cybersecurity services county wide and represents an increase of \$343,128 from last fiscal year to include one additional full-time security staff member and additional services that will provide the county with more robust monitoring and remediation services. A market analysis was conducted by Procurement for this agreement.
