SUPPLEMENTAL CARBON FOR WATER RECLAMATION FACILITIES**

By mutual agreement, the contract is changed as follows:

1. The Contract was executed in the amount of \$1,284,500 for the base period.
2. This contract is hereby renewed for one (1) additional year period:  
9/12/2025 – 9/11/2026 in the amount of \$1,352,450.05.
3. In accordance with changes in the **Producer Price Index**, all unit prices are increased by 5.29% from the initial contracted rates. The unit rates are changed as follows:

Description	Current Unit Rates	Increase, per PPI (5.29%)	New Unit Rates
Supplemental Carbon Bulk Delivery	\$3.35	\$0.177	\$3.53
Supplemental Carbon Totes Delivery in 250 Gallon Totes	\$1,875	\$99.188	\$1,974.19

All other terms, conditions and prices remain unchanged.





