TITLE: Approve Piggyback for Web-Based Electronic Procurement Bidding System

I. MOTION REQUESTED

A) Approve Piggyback No. PB240083KLB to utilize pricing on the Choice Partners Contract No. 21/062KN-02 for Web-Based Electronic Bidding System, with Ion Wave Technologies, LLC for the purchase of web-based electronic procurement bidding system, for a total spend of \$391,035.00 over a five-year period.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contract and to execute all associated documents, as approved in the department's annual adopted budget, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s).

II. ITEM SUMMARY

This item approves the use of piggyback pricing on the Choice Partners Contract for Web-Based Electronic Bidding System, with Ion Wave Technologies, LLC for the purchase of web-based electronic procurement bidding systems in the amount of \$391,035.00 over a five-year period. A market analysis was completed and the purchase under this contract will represent a savings of 23.47% or \$119,940.00 over five years.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

This item approves a piggyback purchase of web-based electronic procurement bidding systems from Ion Wave Technologies, LLC via the Choice Partners Contract. Utilization of Ion Wave allows for consistency with existing web-based electronic procurement software as the County already uses the software to track its contracts. The purchase through the piggyback represents a 23.47% savings from list price over a five-year period.
