TITLE: Approve Piggyback Renewal for Network and Security Operation Services

I. MOTION REQUESTED

- A. Approve Piggyback No. PB250367KLB to utilize pricing on the Florida Department of Management Services/NASPO ValuePoint - Contract No. 43220000-NASPO-19-ACS for Data Communication Products and Services with Driven Tech, Inc. dba Driven Technologies, for the purchase of network and security operations for 24/7 monitoring of enterprise-wide network server and voice infrastructure through the contract expiration date of September 30, 2026, in the amount of \$1,082,982.00.
- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves a piggyback purchase from Driven Technologies to use pricing on the Florida Department of Management Services/NASPO ValuePoint Contract. The contract amount is \$1,082,982.00 and is for a term of two years. This renewal will provide continued 24/7 enterprise-wide network and security monitoring, as well as datacenter, network and voice infrastructure support.

Using the piggyback method allows the County to take advantage of large-scale contract volume discounts. The County benefits from a shorter timeframe because a competitive procurement process has already been conducted. A market analysis was completed and the purchase under this contract will represent savings of \$602,991.60 or 52.66% from the previous contract.

III. BACKGROUND AND IMPLICATIONS OF ACTION

The expiration date of the Florida Department of Management Services/NASPO ValuePoint - Contract No. 43220000-NASPO-19-ACS for Data Communication Products and Services is September 30, 2026, but per the contract terms the duration of purchase order for recurring deliverables shall not exceed the expiration of the Contract by more than twelve (12) months past the then-current termination date of this Master Agreement. The agreement with Driven Tech, Inc. dba Driven Technologies will expire on September 30, 2027.
