

SECOND AMENDMENT OF THE AGREEMENT FOR PARTS AND  
REPAIR SERVICE FOR SPRINTERS WITH MERCEDES ENGINES

THIS SECOND AMENDMENT OF THE AGREEMENT FOR PARTS AND REPAIR SERVICE FOR SPRINTERS WITH MERCEDES ENGINES is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and SAI Fort Myers M, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase service and repair of Sprinters with Mercedes engines, as well as original equipment manufacturer (OEM) parts, accessories, tools, and lubricants for warranty repairs through Solicitation No. B200483MIF with Vendor on the 28<sup>th</sup> day of April, 2021 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that the County needed additional products from the Vendor, which the Vendor could not provide at the specific reduced catalog price, as listed in the Exhibit B. Fee Schedule; and,


WHEREAS, the Parties desire to modify the Agreement, pursuant to Article XV. MISCELLANEOUS of the Agreement, to change the pricing structure from a percentage off of catalog price for products to a percentage above the Vendor's cost price for the products, to allow the Vendor to offer all of the products the County needs.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following Fee Schedule shall supersede the existing Fee Schedule in Exhibit B of the Agreement:


