5.	Please identify the lining process(es) that are permitted for the project? RICIPP, Slip Lining, UV Cured?
Answer	The lining processes permitted for this project are RICPP and UV Cured.
6.	Please identify the curing method(s) that are permitted for the RICIPP installationWater, Air/Steam, or both?
Answer	Both are acceptable.

	Can the Owner please provide/identify a location for the disposal of sand/debris from the pipe cleaning operations?
7.	Can item J on page 68, referring to real-time video monitoring of liner installation, be removed from the contract? This is not a normal Standard Operating Procedure and may cause issues with the tube and/or equipment
Answer	during the installation process.   It is the Contractor's responsibility to find a location that comply with all applicable laws and regulations for debris disposal.   Item J on Page 68 can be removed, it won't be required for this project.
8.	Is Injection Grouting expected to be performed on the project?
