REGARDING the renewal of the contract with BDC Shell and Agg/barclay development

IN our current contract the rates for transport is

South of the River 6.90 for transport cost
and Boca Grand 11.00 per ton transport

Last year we were ask to haul to Sanibel which is not on our list of cost
The cheapest trucking we could find anywhere was 12.90 per ton and cost of the tolls

Based on that we are requesting to add the line for Sanibel area to be 12.90 for hauling cost
the materials would remain the low rate of 3.80 which is not offered anywhere in todays market
WE are not asking for any changes in that or the other haul rates, only to add one for Sanibel
to allow us to assist you for that area

Historically we have also passed the savings to Lee County, any time we have been able to get cheaper
trucking for any reason.

Trucking has gone up so much the past year and continues to do so,
But we did not have any coverage for that area to allow us to assist any request of delivery.

Please advise if this is possible

If not we would not want to change our current numbers and would like to agree to a renewal with Lee County
Accordingly

However, we would not be able to offer trucking to Sanibel at the numbers on the current agreement.
