#### I. MOTION REQUESTED

- A. Award Invitation to Bid No. B240569WCD, Pro-Am Stadium Pressure Washing to Mega Service Solutions Inc, Midlands Pressure Wash Services, and Bel Air Maintenance, Inc. to provide pressure washing services at pro-am stadiums on an as-needed basis for three years, as approved in the departments' annual adopted budgets.
- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C. Grant the County Manager or designee the authority to renew the contracts for up to two additional years and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

Awards annual contracts to Mega Service Solutions Inc, Midlands Pressure Wash Services, and Bel Air Maintenance, Inc. for pressure washing services at the Pro-Am Stadiums on an as-needed basis for a period of three years with an option to renew up to two additional years, as approved in the departments' annual adopted budgets. The total amount spent on pressure washing services at the Pro-Am Stadiums over the past three years, FY23, FY24, and FY25, was \$346,870.00.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

On January 21, 2025, Procurement Management Advertised B240569WCD Pro-Am Stadium Pressure Washing for Lee County to obtain bid submissions for pressure washing services for pro-am stadiums on behalf of the Board of County Commissioners. On the Bid deadline of February 25, 2025, Procurement Management received fourteen bid submissions. Based on the bid submission pricing, it is recommended each facility location be awarded to a primary and secondary vendor to the firm that supplied the lowest pricing for each location as defined below:
