1.	Regarding the contract Professional Services for Development of Surface Water Management Plans (CN180146DLK), is it the County's intent to issue 1, 2, or more consulting contracts from this RFP?
Answer	In order to complete the project within 270 days, as stated, the County prefers to choose multiple consultants. However, the County may consider selecting a single firm if a firm can demonstrate that the firm has qualifications and resources necessary to complete the project within 270 days.
2.	Can you please confirm the County's intention regarding the selection of a single consultant or several consultants for this contract?
Answer	See the answer in question # 1.
3.	Is it the County's intent to award this project to one Firm, multiple Firms, or will the County decide later if they will award to a single firm or multiple firms. I.e is it your intent to select a library of consultants?
Answer	See the answer in question # 1.
4.	In regards to Requires Form 1a Minimum Requirements Table (Page 24), is this form intended to identify the same relevant projects described in the TAB 1 section of the response?
Answer	Form 1a is provided for your response to Tab 1/Criteria 1 found on page 18.

5.	Also, on Form 1a, is the bottom section intended to be for different information or to identify additional relevant projects, if applicable?
Answer	Bottom of Form 1a is for additional projects that your firm may want to add.

6.	In regards to the Reference Survey forms (Form 3), do the references need to be same client for the relevant projects described in TAB 1 or can they be related to different projects?
Answer	The Reference Survey Forms can be from the clients as referenced on Form 1a or from different clients not related to the projects listed in Form 1a.

7.	Is it the intent of the County to select one consultant team to provide the listed services for all of the study areas shown in Attachment 1 or will the County hire a firm for each study area?
Answer	See the answer in question # 1.
