FOURTH AMENDMENT OF THE AGREEMENT FOR PURCHASE & DELIVERY OF BOTTLED WATER - ANNUAL

THIS FOURTH AMENDMENT OF THE AGREEMENT FOR PURCHASE & DELIVERY OF BOTTLED WATER - ANNUAL, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and DS Services of America, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County executed an Agreement for the purchase of the supply and delivery of bottled water, including water-dispensing equipment, through Solicitation B200106DWJ with Vendor on the 27th day of April, 2020 ("Agreement");

WHEREAS, the Parties mutually agree to increase the price for the purchase of the supply and delivery of bottled water, including water-dispensing equipment, from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase shall go into effect starting April 21 2023; and,

WHEREAS, after the execution of the Agreement the Vendor advised that inventory for Item 2: Purified 1 Gallon Bottled Water, offered at 6 per Case, will soon be depleted, and desires to add Item 15: Purified 1 Gallon Bottled Water, offered at 3 per Case, to replace it; and,

WHEREAS, the Parties desire to modify the aforementioned terms of the Agreement, to increase the price for the purchase of the supply and delivery of bottled water and add Item 15: Purified I Gallon Bottled Water, offered at 3 per Case, pursuant to Article XVI. Miscellaneous of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective April 21, 2023, the following Fee Schedule shall supersede the existing Fee Schedule in Exhibit B of the Agreement:
