THIS THIRD AMENDMENT OF THE ANNUAL AGREEMENT FOR PURCHASE & SUPPLY OF SOD made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Juniper Landscaping of FL, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase and supply of sod through Solicitation B210047MIF with Vendor on the 12th day of April, 2021 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the rate for the purchase and installation of various sod products and the unreturned pallet charge from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 16th day of March, 2024; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective March 16, 2024, the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:






