MOTION REQUESTED

A) Approve contract renewal and Amendment No. 3 for the purchase & supply of sod, from Juniper Landscaping of FL, LLC fka Battista Farms, LLC., under Solicitation No. B210047MIF, through March 15, 2027, to increase the fee schedule on average of 12.70%.

B) Approve contract renewal and Amendment No. 1 for the purchase & supply of sod, from Triple J Grassing, under Solicitation No.

B210047MIF, through March 15, 2027, to increase the fee schedule on average of 16.12%.

C) Authorize the County Manager or designee to execute the amendments on behalf of the Board of County Commissioners.

ITEM SUMMARY II.

Approves a contract amendment with Juniper Landscaping of FL, LLC (fka Battista Farms, LLC) and Triple J Grassing, under the solicitation for the purchase & supply of sod, to increase the fee schedules on average by 12.70% and 16.12%, respectively. The amendment will increase the contract amount by \$4,682.39 annually and \$46,037.93 overall. Total expenditures during Fiscal Year 2022-23 were \$891,454.01. Approves the contract renewal through March 15, 2027.

> On March 16, 2021, the Board of County Commissioners awarded B210047MIF Purchase & Supply of Sod, to Juniper Landscaping of FL, LLC fka Battista Farms, LLC and Triple J Grassing, for the purchase and supply of sod. The original term of the contract was for one-year with an option to renew for up to three years.

On August 3, 2021, Juniper Landscaping of FL, LLC fka Battista Farms, LLC amended the fee schedule for pallets.
