On April 26, 2021, Lee County entered into an Agreement with Triple J Grassing, LLC for the purchase and supply Argentine Bahia, 419 Bermuda, Floratam, and "Empire" Zoysia and installation of sod, on an as needed basis through Solicitation No. B210047MIF. On March 17, 2026, Lee County's Board of County Commissioners awarded a new Agreement for the purchase and supply of sod to Triple J Grassing, LLC, and other vendors, through Solicitation B250411LND, that was effective immediately.

As a result, pursuant to Section XII. Termination, of the Agreement for Purchase & Supply of Sod, the County is exercising its right to terminate the prior Agreement, through Solicitation No. B210047MIF, for convenience. In compliance with the termination procedures established by Section XII, the Agreement shall terminate as of April 27, 2026. Commencing upon the date of receipt of this Notice, the County is mandating a suspension of any remaining work under the prior Agreement and all future work shall be performed under the new Agreement, through Solicitation B250411LND.
