#### I. MOTION REQUESTED

A) Award Invitation to Bid No. B200270MIF, Purchase of Fungicides, Herbicides & Pesticides for the purchase and delivery of fungicides, herbicides & pesticides, on an as needed basis, for an initial term of one year, as approved in the departments' annual adopted budgets, in the amount not to exceed \$185,500.00 annually to the following vendors: Ensystex II, Inc., Mar Green Resources, LLC, Nutrien Ag Solutions, Inc., Red River Specialties, LLC, SiteOne Landscape Supply, LLC, and Winfield Solutions, LLC.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts for up to one additional year, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

#### II. ITEM SUMMARY

Awards contracts to Ensystex II, Inc., Mar Green Resources, LLC, Nutrien Ag Solutions, Inc., Red River Specialties, LLC, SiteOne Landscape Supply, LLC, and Winfield Solutions, LLC, to provide the supply and delivery of fungicides, herbicides & pesticides to County departments, on an as-needed basis for an initial one-year period in an amount not to exceed \$185,500.00 per year. The contracts can be renewed for up to one year, upon the agreement of all parties. Total expenditures for these services for Fiscal Year 2018-2019 were \$185,500.00.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Procurement Management obtained bids for the project known as Invitation to Bid No. B200270MIF, Purchase of Fungicides, Herbicides & Pesticides. On the bid deadline of June 17, 2020, Procurement Management received seven submittals. After conducting an analysis of the bid submissions Ensystex II, Inc., Mar Green Resources, LLC, Nutrien Ag Solutions, Inc., Red River Specialties, LLC, SiteOne Landscape Supply, LLC, and Winfield Solutions, LLC were determined to be the responsible and responsive bidders.

Staff recommends awarding contracts to Ensystex II, Inc., Mar Green Resources, LLC, Nutrien Ag Solutions, Inc., Red River Specialties, LLC, SiteOne Landscape Supply, LLC, and Winfield Solutions, LLC for use on an as-needed basis.
