II. ITEM SUMMARY

Approves the renewal to the agreements for custodial services with American Facility Services, At Your Service, Inc., and United States Service Industries, (USSI), through September 30, 2022. Approves an amendment with USSI, providing for a Consumer Price Index Increase of 4% for all items listed on the fee schedule of the amended contract. This is the final renewal for this contract.
