FOURTH AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR LEE COUNTY CENTRAL ZONE

THIS FOURTH AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR LEE COUNTY CENTRAL ZONE, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") American Facility Services, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for Lee County Central Zone through Solicitation No. RFP180119MRH with Vendor on the 14th day of August, 2018 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interest of the County to add an additional custodial service location, the Fleet Management Satellite Shop, to the Exhibit A, Scope of Services; and,

WHEREAS, pursuant to Article XIV. MISCELLANEOUS of the Agreement, the Parties desire to modify Exhibit A, Scope of Services to add the new service location; and,

WHEREAS, pursuant to Article V. ADDITIONAL PURCHASES of the Agreement, the Parties desire to change the accompanying pricing in the Exhibit B, Fee Schedule.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

 The Parties agree that the Exhibit A, Scope of Services, section titled "County Facilities Included Under This Agreement" shall be supplemented by the following:

FLEET MANAGEMENT SATELLITE SHOP

Location: 5180 St, Fort Myers, FL 33905 Hours of Operation: 7:00-3:30

Scheduling

The Fleet Management Satellite Shop shall be cleaned on Tuesday and Friday evenings, after 3:30 p.m., unless otherwise instructed/approved by the Operations Manager.

Cleaning shall be performed on a two-day per week basis, excluding holidays.

The Vendor will be given a minimum of 48 hours' notice of any schedule change.

Weekly service

All Areas

- Wipe down all doors and doorknob hardware.
- Empty trash and replace trashcan liners, as needed, and wipe out trashcans, if dirty.
- Wipe all light switches and surrounding areas.
- Damp wipe all windowsills.
- Remove any cobb webs.

Front Office Area - Common Waiting Area

- Front office damp wipe all walls when necessary.
- Sweep and mop vinyl floors and clean/shake mats.
- Dust the desks and counter tops, tables etc. (provided that the articles on the desk are removed by the employee).

Break Room and Kitchen off the Front Offices

- Wipe the table with disinfectant.
- Sweep and mop vinyl floors.
- Vacuum mats.
- Clean the countertops.
- Replace paper towels, place unused towels on table/counter.
- Wipe the front of appliances.

All Restrooms Areas

- Clean sinks, toilets, and mirrors with a disinfectant.
- Sweep and mop the floors.
- Wipe paper towel dispensers, soap dispenser and walls, if needed, with a disinfectant.
- Replace toilet paper, paper towels, and soap if needed
- Sweep and mop the floors.

Semi-annual service

- Dust and clean all ceiling vents and lighting fixtures, using all purpose cleaner/disinfectant.
- Clean the chairs and legs in the lunchroom and shop area.
- Clean all interior windows, as needed.

Special Cleaning Tasks: Strip and wax floors as requested.
