TITLE: Award Service Contract for Removal of Derelict and Abandoned Vessels

Ī. MOTION REQUESTED

- A. Award Request for Proposal No. RFP170338LKD, Removal of Derelict and Abandoned Vessels, to TSI Disaster Recovery, LLC and Southwest Florida Maritime, Inc. d/b/a Sea Tow Fort Myers to provide removal of derelict and abandoned vessel services for an initial term of one year.
- B. Grant the Director of Procurement Management the authority to negotiate and approve Supplemental Task Authorizations for vessels added to the contract on an as-needed basis in a total amount not to exceed the department's annual adopted budget. A single removal project shall not exceed \$200,000.00.
- C. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- Grant the Director of Procurement Management the authority to negotiate renewals of the contract, and to execute renewal documents for up to three additional one-year periods, with County Administration approval, as approved in the department's annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Award Request for Proposal No. RFP170338LKD, Removal of Derelict and Abandoned Vessels, to TSI Disaster Recovery, LLC and Southwest Florida Maritime, Inc. d/b/a Sea Tow Fort Myers to provide removal of derelict and abandoned vessel services for an initial term of one year. Fiscal Year 2016-2017 expenditures were approximately \$110,000 for these services. This item is approved in the

III. **BACKGROUND AND IMPLICATIONS OF ACTION**

Board Action and Other History

The Lee County Natural Resources Department is responsible for the removal of derelict and abandoned vessels in Lee County. Natural Resources submitted a request to Procurement Management to obtain proposals on behalf of the Board of County Commissioners for the project known as RFP170338LKD, Removal of Derelict and Abandon Vessels.

On the established proposal deadline of August 15, 2017, Procurement received three proposals. An evaluation meeting was held on August 31, 2017 during which the Evaluation Committee considered criterion as listed in the solicitation request including such items as Similar Work Experience, Firm Plan of Approach/Equipment Availability, Personnel/Resources and Financial Qualifications of the Company as detailed in the solicitation. On the basis of the information submitted by the firms in their proposals, it was the consensus of the Committee to recommend to the Board the ranking as follows: 1) TSI Disaster Recovery, LLC. 2) Southwest Florida Maritime, Inc. d/b/a Sea Tow Fort Myers 3) Southwest Florida Marine and Boat Works LLC

The Evaluation Committee unanimously recommends award to 1) TSI Disaster Recovery, LLC. 2) Southwest Florida Maritime. Inc. d/b/a Sea Tow Fort Myers

The contract term will be for a one-year period beginning at the execution of the Agreement by both parties. There may be an option to extend the contract for up to three additional one-year periods, upon the approval of both parties and appropriation of funds.

Lee County Division of Natural Resources works with Marine Law Enforcement to investigate potential derelict or abandoned vessels in accordance with administrative code 7-10. If responsible parties can not be found to remove the vessel, county removes in order to prevent navigation hazards and environmental degradation. On average, 50 cases are closed each year. Having annual contracts allows for timely vessel removal when needed and ensures qualified vendors are available.
