

FIRST AMENDMENT OF AGREEMENT FOR PAINT
AND PAINT CONTRACTOR SERVICES

THIS FIRST AMENDMENT OF AGREEMENT FOR PAINT AND PAINT CONTRACTOR SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and McLeod's Construction, Paint & Restoration, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County executed an Agreement for the purchase of paint and paint contractor services through Solicitation RFP170458LKD with Vendor on the 28th day of March, 2018 ("Agreement");

WHEREAS, the County has modified its notice procedures for the types of services performed under the Exhibit B Fee Schedule of this Agreement; and,

WHEREAS, the Parties desire to raise the bond requirement in the Exhibit A Detailed Scope of Work from \$100,000.00 to \$200,000.00; and,

WHEREAS, the Parties desire to update the Agreement with the correct terminology pursuant to Article XVI. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The entirety of the section titled "Notice to Proceed (NTP)" in the Exhibit B Fee Schedule shall be superseded by:

"3. Notice Procedures

3.1 Unless otherwise stated in the purchase order, all projects shall use the date indicated in the purchase order as the notice to proceed date. The start date and the number of calendar days to complete the project must be included on the purchase order. If the start date is left off the purchase order, then the date of the purchase order approval shall default as the notice to proceed start date and the default date for completion of services shall be the 20th calendar day after the start date."

2. The Parties agree that the term "\$100,000.00" in the Exhibit A Detailed Scope of Work shall be superseded by "\$200,000.00."
