THIS SECOND AMENDMENT OF AGREEMENT FOR REAL ESTATE APPRAISAL SERVICES COUNTY WIDE AND/OR CONSERVATION 20/20 LANDS PROGRAM, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Kova Appraisal & Consulting Services, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, County and Vendor desire to enter into this Second Amendment to continue their Agreement via Solicitation No. RFP170475GWT under the Vendor's new business name.


