- For each County Project Authorization authorizing work for a cost of \$100,000.00 or more, the Contractor shall procure performance and payment bonds in accordance with Exhibit D Performance and Payment Bonds of this Agreement, attached and the Solicitation

Change Orders to County Project Authorizations:

A modification to a County Project Authorization may be authorized by a County Project Modification properly executed by both parties.
