TITLE: Approve Contract Extension for Custodial Services for Lee County North Zone

I. MOTION REQUESTED

A) Approve three-month contract extensions with American Facility Services, Inc., and United States Services Industries (USSI), under Solicitation No. RFP180120MRH, for custodial services at County facilities located in the North Zone, through December 31, 2022. B) Authorize the County Manager or designee to execute the extension documents on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves a three-month extension for American Facility Services, Inc., and United States Services Industries (USSI), for the annual contract for custodial services at County facilities located in the North Zone through December 31, 2022. The extension is required to allow time to complete the competitive solicitation process. Total expenditures to provide these services during Fiscal Year 2021-2022 through 8/31/2022 were approximately \$577,986.89.

III. BACKGROUND AND IMPLICATIONS OF ACTION

On August 21, 2018, the Board approved contracts under Solicitation No. RFP180120MRH Custodial Services for Lee County North Zone. Contracts were awarded to Florida Cleaning Systems, Inc., American Facility Services, Inc., and United States Service Industries, Inc., (USSI) for an initial term of one year with an option to renew for three additional years. Florida Cleaning Systems, Inc., was eventually terminated. Board approval will allow a three-month extension to continue these services through December 31, 2022, allowing time to complete the competitive solicitation process.
