TITLE:

Approve Contract Extension for Custodial Services for Lee County South Zone

1. MOTION REQUESTED

A) Approve a four-month contract extension for custodial services at County facilities located in the South Zone, from American Facility Services, Inc., and United States Services Industries (USSI), under Solicitation No. RFP180122MRH, through March 31, 2023. B) Grant the County Manager or designee the authority to extend the contract for four months, and to execute all associated documents, as approved in the departments' annual adopted budgets.

II. ITEM SUMMARY

Approves a four-month extension for American Facility Services, Inc., and United States Services Industries (USSI), for the annual contract for custodial services at County facilities located in the South Zone through March 31, 2023. The extension is required to allow time to complete the competitive solicitation process. Total expenditures to provide these services during Fiscal Year 2021-2022 through 7/29/2022 were approximately \$1,736,147.09.

Board Action and Other History

On November 6, 2018, the Board approved contracts under Solicitation No. RFP180122MRH Custodial Services for Lee County South Zone. Contracts were awarded to American Facility Services, Inc., and United States Service Industries, Inc., (USSI) for an initial term of one year with an option to renew for three additional years. Board approval will allow a four-month extension to continue these services through March 31, 2023, allowing time to complete the competitive solicitation process.
