Dear, Mr. McCann:

On October 9, 2018, Lee County entered into an annual agreement with American Facility Services, Inc. for Custodial Services for Lee County South Zone, under Solicitation No. RFP180122MRH. Following the landfall of Hurricane Ian on September 28, 2022, the Lakes Regional Library, located at 15290 Bass Road, Fort Myers, FL 33919, has been closed to the public and is being used as a Disaster Recovery site. As a result, the library does not require the usual cleaning services, as agreed to in the Custodial Services for Lee County South Zone agreement, under Solicitation No. RFP180122MRH.

Pursuant to the COUNTY FACILITIES INCLUDED UNDER THIS AGREEMENT section, of Exhibit A. Scope of Services, of the agreement, the County is exercising its right to temporarily stop the agreed upon custodial services at the Lakes Regional Library. This stoppage of services shall be effective immediately and run until further notice from Lee County. However, as discussed with Library staff, the altered cleaning services, for use of the Lakes Regional Library as a Disaster Recovery site, shall continue and paid under a separate emergency relief quote.
