("Vendor"), collectively, the "Parties."

WHEREAS, the Parties mutually agree to increase the price for the purchase of custodial services for Lee County South Zone; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 1st day of December, 2020; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XIV. MISCELLANEOUS of the Agreement.

- 1. The price increase will begin on the 1st day of December, 2020
