RE: RFP180122MRH - CUSTODIAL SERVICES FOR LEE COUNTY SOUTH ZONE – TEMPORARY STOPPAGE OF SERVICE – SEVERAL PARKS LOCATIONS

Dear, Mr. McCann:

On October 9, 2018, Lee County entered into an annual agreement with American Facility Services, Inc. for Custodial Services for Lee County South Zone, under Solicitation No. RFP180122MRH. Following the landfall of Hurricane Ian on September 28, 2022, several Lee County parks were severely damaged and are no longer open for public use and will not be for an extended period. As a result, cleaning services are no longer required at the following locations, until further notice by the County:

1. Bonita Beach Parks located at 27551 S Tamiami Trail, Bonita Springs, FL
2. Imperial River Boat Ramp located at 27950 Hickory Blvd, Bonita Springs, FL
3. Lynn Hall Park located at 950 Estero Blvd, Fort Myers, FL
4. Crescent Family Beach Park located at 1100 Estero Blvd, Fort Myers, FL
5. Bowditch Point Regional Park located at 50 Estero Blvd, Fort Myers, FL

Pursuant to the COUNTY FACILITIES INCLUDED UNDER THIS AGREEMENT section, of Exhibit A. Scope of Services, of the agreement, the County is exercising its right to temporarily stop custodial services at the above-listed locations. This stoppage of services shall be effective immediately and run until further notice from Lee County.
