On October 9, 2018, Lee County entered into an annual agreement with American Facility Services, Inc. for Custodial Services for Lee County South Zone, under Solicitation No. RFP180122MRH. Following the landfall of Hurricane Ian on September 28, 2022, Lakes Regional Park, located at 7330 Gladiolus Drive, Fort Myers, FL, sustained damage that renders custodial services no longer necessary, until further notice.

Pursuant to the COUNTY FACILITIES INCLUDED UNDER THIS AGREEMENT section, of Exhibit A. Scope of Services, of the agreement, the County is exercising its right to temporarily stop custodial services at the Lakes Regional Park service location at 7330 Gladiolus Drive, Fort Myers, FL. This stoppage of services shall be effective immediately and run until further notice from Lee County.

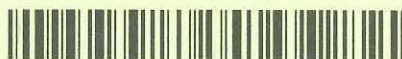
