

FIRST AMENDMENT OF THE GROUP VISION CARE POLICY AGREEMENT

THIS FIRST AMENDMENT OF THE GROUP VISION CARE POLICY AGREEMENT, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the state of Florida, hereinafter referred to as the "County," and Vision Service Plan Insurance Company, hereinafter referred to as the "Vendor."

WHEREAS, the County entered into an Agreement for group vision care policy services, Contract Number 8268 through Solicitation Number RFP180163LKD, with Vendor on the 2nd day of January, 2019 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that additional contract term information was necessary to clarify the rate and term of the Agreement; and,

WHEREAS, it was discovered after the execution of the Agreement that one of the proposed pricing provisions had erroneously ended up in the executed Agreement instead of the appropriate negotiated final pricing provision; and,

WHEREAS, County and Vendor desire to remedy this error and clarify the terms pursuant to Section 5.01, General, of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. On page 1 of the Agreement, next to the Policy Term section, the provision stating: "THIRTY-SIX (36) MONTHS" shall be superseded by: "FORTY-EIGHT (48) MONTHS."
2. In Article 2.01 of the Agreement, the provision stating: "The rate established in the initial one-year term is guaranteed for three years and shall not increase during the Policy Term." shall be superseded by: "The rate established in the initial one-year term is guaranteed for four (4) years and shall not increase during the Policy Term."


3. The price "\$9.62" in the Exhibit B Schedule of premiums, and all other uses of that price throughout the Agreement and its Exhibits, Riders, and Attachments, shall be superseded by "\$9.43."
4. The price "\$18.75" in the Exhibit B Schedule of premiums, and all other uses of that price throughout the Agreement and its Exhibits, Riders, and Attachments, shall be superseded by "\$18.38."
5. The price "\$16.75" in the Exhibit B Schedule of premiums, and all other uses of that price throughout the Agreement and its Exhibits, Riders, and Attachments, shall be superseded by "\$16.42."
6. The price "\$32.00" in the Exhibit B Schedule of premiums, and all other uses of that price throughout the Agreement and its Exhibits, Riders, and Attachments, shall be superseded by "\$31.36."
