Award Contract for Landscape Mowing and Maintenance for LeeTran

I. MOTION REQUESTED

A) Award Request for Proposal No. RFP180331KLC Landscape Maintenance and Mowing for LeeTran to Big Tree, Inc. for a period of two years, to provide landscape maintenance and mowing for LeeTran, as approved in the department's adopted budget.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Authorize the Director of Procurement Management to add or delete work/services as needed and to execute all associated

documents.

D) Grant the Director of Procurement Management the authority to negotiate renewals of the contract, including changes in price, for up to three additional one-year periods, in accordance with the contract, and to execute all associated documents, with County Administration approval, as approved in the department's annual adopted budget, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Award contract for landscape maintenance and mowing for LeeTran to Big Tree, Inc. to provide edging, string trimming, trimming shrubs, pruning trees and palms, weeding, fertilizing, irrigation services, supplying replacement trees and shrubs, etc. This contract is for an initial period of two years with the option to renew for three additional one-year periods. Total expenditures during Fiscal Year 2016 – 2017 were approximately \$104,026.00.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On May 18, 2018, Procurement Management advertised Request for Proposal No.RFP180331KLC Landscape Maintenance and Mowing for LeeTran. On the proposal deadline, June 26, 2018, Procurement Management received four proposals. One vendor was deemed non-responsive due to the preparation of his package. On July 24, 2018, the Evaluation Committee met to evaluate the proposals based on criteria from the solicitation such as company history, personnel, licenses and certification, equipment and references. The committee decided to open the pricing from the two top ranked vendors Big Tree, Inc. and Personal Touch Landscaping. The committee recommends awarding the contract to Big Tree, Inc., the responsive, responsible proposer meeting all specifications with the lowest price.

Total expenditures during Fiscal Year 2016 - 2017 were approximately \$104,026.00.
