("County") and Big Tree, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of landscape maintenance and mowing services for Lee Tran through Solicitation No. RFP180331KLC with Vendor on the 24<sup>th</sup> day of October 2018 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for landscape maintenance and mowing services; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 24<sup>th</sup> day of October, 2019; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XVI. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

- 1. The Parties agree that the price increase will begin on the 24th day of October, 2019.
