

SECOND AMENDMENT OF THE AGREEMENT FOR
ENVIRONMENTAL MAINTENANCE SERVICES (EXOTIC PLANT CONTROL)

THIS SECOND AMENDMENT OF THE AGREEMENT FOR ENVIRONMENTAL MAINTENANCE SERVICES (EXOTIC PLANT CONTROL), is made and entered by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Seven Isles Capital dba DeAngelo Contracting Services, LLC dba Aquagenix ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for environmental maintenance services, Contract No. 8164, through Solicitation No. RFP180418JJB with Vendor on the 15th day of November, 2018 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was DeAngelo Brothers, LLC dba Aquagenix, with a Federal Tax ID Number of 23-2332783; and,

WHEREAS, after execution of the Agreement, DeAngelo Brothers, LLC dba Aquagenix was acquired by, and merged into, Seven Isles Capital dba DeAngelo Contracting Services, LLC dba Aquagenix, with a new Federal Tax ID Number of 85-0542566; and,

WHEREAS, County and Vendor desire to enter into this Second Amendment to continue their Agreement via Solicitation No. RFP180418JJB under the Vendor's new business entity.


NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Seven Isles Capital dba DeAngelo Contracting Services, LLC dba Aquagenix, shall continue to supply such services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. RFP180418JJB, including appendices and amendments, and Vendor's response.


