SECOND AMENDMENT OF THE MASTER SERVICES AGREEMENT FOR
INFORMATION TECHNOLOGY OUTSOURCED SERVICES

THIS SECOND AMENDMENT OF THE MASTER SERVICES AGREEMENT FOR INFORMATION TECHNOLOGY OUTSOURCED SERVICES made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Computer Aid, Inc. ("Service Provider"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of information technology outsourced services through Solicitation No. RFP190016DLK with Service Provider on the 21st day of May, 2019 ("Agreement"); and,

WHEREAS, on April 29, 2021, the County advised the Service Provider of their intention to discontinue Service Tower Agreements for towers 1 through 7, leaving only towers 5 and 6 active, effective August 4, 2021; and,

WHEREAS, the Parties mutually agree to increase the rate for the purchase of the remaining service towers of information technology outsourced services, to be effective the 5th day of August 2025; and,

WHEREAS, pursuant to Article 3.2.7, Amendment of the Agreement the Parties desire to modify the Agreement to increase the rate for the purchase of information technology outsourced services in Tower 5 - Application Services and Tower 6 - End User Technologies Services of the Agreement, from the Service Provider.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:
