1. QUESTIONS/ANSWERS

1.	I wanted to know if we could have the approx. thickness of the blue-green algae,
	that way we can give a better cost estimated and plan.
Answer	All technologies will be considered from treating the top most mats, to
	treating the whole water column. For purposes of preparing a cost estimate
	and plan, a depth of 1 foot should be used.
2.	Do the following required submittals count towards the page limit: résumés,
	licenses, and bonding letter?
Answer	No, this does not count towards page count.
3.	Should required information on a form need to be answered in an attachment,
	does it count towards the page limit?
Answer	Any forms under Tab 7 (required forms) do not count towards page limit
	in proposal.
4.	Tab 3 asks for a detailed plan of approach and Tab 4 asks for a detailed proposal
	of our methods on our letterhead.
	a. What is the difference between these two sections?
	b. As we have a page limit, are we allowed to not repeat the information?
Answer	a. Tab 3 is how your technology will be implemented at any given site
	and conditions. This should include any limiting conditions of the
	proposed technology.
	b. Tab 4 shall describe the method of treatment/collection/disposal for
	the hypothetical remediation of a toxic algae bloom, such as blue-
	green algae, of approximately 100'x100' in area and 1' in depth
	within a local County waterway.
5.	How will the final disposal of remediated algae be done?
	a. Will Proposers be responsible?

	b. Should proposer be responsible for cost?
	c. Possibility to bring new type of disposal within the proposal?
Answer	Disposal is a key component of the methods and will be part of the
	Proposer's costs to the maximum extent possible. Solids and liquids
	resulting from the remediation process must comply with all laws,
	ordinances, rules and regulations applicable to the disposal method.
6.	What treatments or remediation techniques are acceptable?
	i.e. chemical, out-side of US under Library review, lab-tested, etc.
Answer	All selected remediation technologies through this solicitation must be
	accepted into the Florida Department of Environmental Protection
	(FDEP) Technology Library prior to County's authorization of any work
	under this contract.
