

FIRST AMENDMENT OF AGREEMENT FOR FERTILIZER
EDUCATION AND OUTREACH PROGRAM

THIS FIRST AMENDMENT OF THE AGREEMENT FOR FERTILIZER EDUCATION AND OUTREACH PROGRAM (“Amendment”) made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida (“County”) and Dickinson & Associates, Inc., a Florida corporation (“Vendor”), collectively, the “Parties”.

WHEREAS, the County entered into an Agreement for Fertilizer Education/Outreach Program Developer, through Solicitation RFP190546AEJ, with the Vendor on the 27th day of April, 2020 (“Agreement”); and,

WHEREAS, after the execution it was determined that it would be in the best interest of the County to reallocate funds within the Exhibit B. Fee Schedule to modify some of the public interaction tasks of the program; and,

WHEREAS, pursuant to Article XVI. MISCELLANEOUS of the Agreement, the Parties desire to modify Exhibit B, Fee Schedule to reallocate the funds.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that Exhibit B Fee Schedule shall be superseded by the following:


