

FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT
FOR MISCELLANEOUS PLANNING SERVICES

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS PLANNING SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Bowman Gulf Coast LLC dba Hole Montes, a Bowman Company ("Consultant"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of miscellaneous planning services through Solicitation RFP200361BAG with Consultant on the 26th day of April, 2021 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Consultant's business entity name was Hole Montes, Inc., with a Federal Tax ID Number of 59-1518838; and,

WHEREAS, after execution of the Agreement, Hole Montes, Inc. was acquired by Bowman Gulf Coast LLC, and began operating as Bowman Gulf Coast LLC dba Hole Montes, a Bowman Company, with a Federal Tax ID Number of 92-2421024; and,

WHEREAS, County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. RFP200361BAG under the Consultant's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Consultant, conducting business as Bowman Gulf Coast LLC dba Hole Montes, a Bowman Company, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. RFP200361BAG, including appendices and amendments, and Consultant's response.
