THIS FIFTH AMENDMENT OF THE AGREEMENT FOR SECURITY GUARD

SERVICES - COUNTY WIDE is made and entered into by and between the Lee County Board

of County Commissioners, a political subdivision of the State of Florida ("County") and Mason

Evans, Inc. DBA Diamond Investigations and Security ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase security guard services

through Solicitation No. RFP210146BJB with Vendor on the 15th day of June, 2022

("Agreement"); and,

WHEREAS, after the execution of the Agreement, a new Lehigh Acres Transfer Center,

located at 1121 Village Lakes Blvd., Lehigh Acres, FL 33972 was opened and requires security

guard services; and,

WHEREAS, after the execution of the Agreement, the Parties determined that several of

the Lee County service locations had incorrect hours listed in the Section 13. LOCATIONS of the

SCOPE OF WORK section of the Exhibit A. SPECIAL CONDITIONS AND SCOPE OF WORK

of the Agreement and that the Old Courthouse service location listed was no longer being serviced

by the Vendor; and,

WHEREAS, the Parties mutually agree to add security guard services for the new Lehigh

Acres Transfer Center to the Agreement, at an anticipated total increase to the annual cost of the

Agreement of \$83,356.00, to correct the schedules of the security guard services being provided

for the Administrative Building, Rosa Parks Transit Center, and Fort Myers Beach Park & Ride

service locations, and to remove the Old Courthouse service location from the Exhibit A.

SPECIAL CONDITIONS AND SCOPE OF WORK of the Agreement; and,

WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties

desire to modify the Lee County Locations table in Section 13. LOCATIONS of the SCOPE OF

WORK section of the Exhibit A. SPECIAL CONDITIONS AND SCOPE OF WORK of the

Agreement to add the Lehigh Acres Transfer Center, correct the aforementioned service location

schedules, and remove the Old Courthouse location.
