NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that immediately following fully execution of this Amendment by all Parties, Exhibit B. Fee Schedule of the Agreement shall be superseded by:

PRICING

Pricing shall be inclusive of all labor, equipment, supplies, overhead, profit, material, and any other incidental costs required to perform and complete all work as specified in the Contract Documents.

Non-Holiday Rate: Hourly rate to be used on days not designated within Section 18.7 of the Exhibit A Special Conditions and Scope of Work of the contract as holidays observed by Lee County.

<u>Holiday Rate</u>: Hourly rate to be used on days that are designated within Section 18.7 of the Exhibit A Special Conditions and Scope of Work of the contract as holidays that are observed by Lee County.
