### THIRD AMENDMENT OF THE AGREEMENT FOR SECURITY GUARD SERVICES - COUNTY WIDE

THIS THIRD AMENDMENT OF THE AGREEMENT FOR SECURITY GUARD SERVICES - COUNTY WIDE is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Mason Evans, Inc. DBA Diamond Investigations and Security ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase security guard services through Solicitation No. RFP210146BJB with Vendor on the 15th day of June, 2022 ("Agreement"); and,

WHEREAS, after the execution of the agreement the County determined that it would be in their best interest to add security guard service rates for Holiday hours in the Exhibit B. Fee Schedule; and,

WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties desire to modify the Exhibit B. Fee Schedule of the Agreement to include Holiday hourly rates.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that immediately following fully execution of this Amendment by all Parties, Exhibit B. Fee Schedule of the Agreement shall be superseded by:

Pricing shall be inclusive of all labor, equipment, supplies, overhead, profit, material, and any other incidental costs required to perform and complete all work as specified in the Contract Documents.			
<u>Non-Holiday Rate:</u> Hourly rate to be used on days not designated within Section 18.7 of the Exhibit A Special Conditions and Scope of Work of the contract as holidays observed by Lee County.			
<u>Holiday Rate:</u> Hourly rate to be used on days that are designated within Section 18.7 of the Exhibit A Special Conditions and Scope of Work of the contract as holidays that are observed by Lee County.
