THIS FOURTH AMENDMENT OF THE AGREEMENT FOR SECURITY GUARD SERVICES - COUNTY WIDE is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Mason Evans, Inc. DBA Diamond Investigations and Security ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase security guard services through Solicitation No. RFP210146BJB with Vendor on the 15th day of June, 2022 ("Agreement"); and,

WHEREAS, after the execution of the Agreement the County determined that it would be in their best interest to add security guard service rates for additional after hours shifts in the Exhibit B. Fee Schedule; and,

WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties desire to modify the Exhibit B. Fee Schedule of the Agreement to include additional after hours shift rates.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:
