SECOND AMENDMENT OF THE AGREEMENT FOR

THIS SECOND AMENDMENT OF THE AGREEMENT FOR SECURITY GUARD SERVICES - COUNTY WIDE is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Mason Evans, Inc. DBA Diamond Investigations and Security ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase security guard services through Solicitation No. RFP210146BJB with Vendor on the 15th day of June, 2022 ("Agreement"); and,

WHEREAS, after the execution of the agreement the County determined that it would be in their best interest to add security guard services for the LeeTran South Transfer Park and Ride station located at 13182 South Cleveland Ave, Ft Myers, 33907; and,

WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties desire to modify the Lee County Locations table in Section 13. LOCATIONS of the SCOPE OF WORK section of the Exhibit A. SPECIAL CONDITIONS AND SCOPE OF WORK of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following Lee County Locations table shall supersede the existing Locations table in Subsection 13.1 of Section 13. LOCATIONS of the SCOPE OF WORK section of the Exhibit A. SPECIAL CONDITIONS AND SCOPE OF WORK of the Agreement:
