

FIFTH AMENDMENT OF THE SOLID WASTE AND RECYCLING COLLECTION
FRANCHISE AGREEMENT FOR LEE COUNTY SERVICE AREA NUMBER FOUR

THIS FIFTH AMENDMENT OF THE SOLID WASTE AND RECYCLING COLLECTION FRANCHISE AGREEMENT FOR LEE COUNTY SERVICE AREA NUMBER FOUR, is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Waste Pro of Florida, Inc. ("Contractor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of waste and recycling collection and hauling services for Franchise Service Area Number Four in Lee County, through Solicitation # RFP220049BJB, with Contractor on the 17th day of June, 2022 ("Agreement"); and,

WHEREAS, Section 6. CHARGES, RATES, PAYMENTS, DISPUTES, and INTEREST RATES of the Agreement permits the Contractor, with County approval, to be granted an annual rate adjustment to the Curbside Residential Solid Waste Collection Service, Commercial Solid Waste Collection Service and Curbside Residential Recycling Collection Service rates in the Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 4 of the Agreement, using a Consumer Price Index ("CPI") calculation outlined in the Agreement; and,

WHEREAS, Amendment No. 3 to the Agreement also allows the CPI increase to be requested for, and applied to, the Vegetative Storm Debris Collection Service rates in the "NOT-TO-EXCEED RATES FOR VEGETATIVE STORM DEBRIS COLLECTION SERVICE" section of the Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 4 of the Agreement;

WHEREAS, the Lee County Board of County Commissioners approves a CPI franchise hauler commercial and residential rate increase of 1.39% for the 2026-2027 Fiscal Year for all the aforementioned waste collection rates in the Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 4 of the Agreement; and,

WHEREAS, County and Contractor desire to enter into this Fifth Amendment to apply the same 1.39% for the 2026-2027 Fiscal Year to the Curbside Residential Solid Waste Collection Service, Commercial Solid Waste Collection Service, Curbside Residential Recycling Collection Service, and Vegetative Storm Debris Collection Service rates listed in the Exhibit II RATE SCHEDULE FOR FRANCHISE SERVICE AREA 4 of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The new increased rates for Curbside Residential Solid Waste Collection Service, Commercial Solid Waste Collection Service, Curbside Residential Recycling Collection Service, and Vegetative Storm Debris Collection Service listed in the updated Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 4, implemented by this Amendment, and included in the updated tables below, shall go into effect on October 1 for the applicable fiscal year listed in the tables.
2. Effective October 1, 2026, the fee table titled “Service Rates for Solid Waste Recycling Collection Franchise Agreement – Service AREA 4” in the newly titled Exhibit II. RATE SCHEDULE FOR FRANCHISE SERVICE AREA 4 of the Agreement shall be superseded by:
