#### TITLE: Approve Amendment for Custodial Services - North Zone

#### I. MOTION REQUESTED

A) Approve Amendment No. 2 to the contract with United States Service Industries, Inc., under Solicitation No. RFP220232SML, Custodial Services for North Zone Lee County. The amendment will update Exhibit A – Scope of Work and Exhibit B – Fee Schedule to include the Health Department – Pondella to provide custodial service at the location.
B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

#### II. ITEM SUMMARY

Approves a contract amendment with United States Service Industries, Inc., under the solicitation for Custodial Services for North Zone Lee County to update Exhibit A – Scope of Work and Exhibit B – Fee Schedule to include the Health Department – Pondella to provide custodial service at the location. The monthly cost for the additional location is \$6,471.32, along with a quarterly services cost of \$183.61 and semiannual services cost of \$1,384.50, for a maximum location cost of \$81,159.28 per year for the life of the contract. Expenditures would be on an as-needed basis, as approved in the departments' annual adopted budget.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

#### A) Board Action and Other History

On December 6, 2022, the Board of County Commissioners awarded RFP220232SML, Custodial Services for North Zone Lee County, to United States Service Industries, Inc. to provide annual custodial maintenance of Depot #1 Natural Resources, Pine Island Library, and Sheriff Substation, North District. The original term of the contract was for 3-years with an option to renew for up to 3 additional years.

On January 18, 2022, Amendment No. 1 was administratively approved to add the pricing for custodial services at for the North Fort Myers Library to the Exhibit B. Fee Schedule, which was included in the County's Notice of Intended Decision and included in the Exhibit A. Scope of Work of the Agreement but was erroneously left out of the Exhibit B Fee Schedule.
