**FIRST AMENDMENT OF THE AGREEMENT FOR
CUSTODIAL SERVICES FOR NORTH ZONE LEE COUNTY**

THIS FIRST AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR NORTH ZONE LEE COUNTY, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and At Your Service Cleaning Group, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for North Zone Lee County through Solicitation No. RFP220232SML with Vendor on the 14th day of December, 2022 ("Agreement"); and,

WHEREAS, after the execution of the Agreement it was discovered that pressure cleaning services were meant to be removed from the Exhibit A. Scope of Work, as the County did not intend for the Vendor to perform the pressure cleaning services; and,

WHEREAS, the Parties agree to remove all references to pressure cleaning services from the Exhibit A. Scope of Work; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective immediately, upon execution by all Parties, all references to pressure cleaning services, specifically in the Subsection 17.4 Quarterly Services of Section 17 SERVICE IDENTIFIERS, shall be removed from the Exhibit A. SCOPE OF WORK section of the Agreement.
