WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties agree to reduce the number of cleanings at the Maintenance Electrical Office at 190 Evergreen Road service location to once monthly.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:
