THIS FOURTH AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES SOUTH ZONE, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") United States Services Industries, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for South Lee County through Solicitation No. RFP220314SML with Vendor on the 16th day of March, 2023 ("Agreement"); and,

WHEREAS, after the execution of the Agreement it was determined that it would be in the best interest of the County to increase the frequency of weekly cleaning services from once per week to twice per week and add quarterly custodial services at the Fleet Management, Lee County Sheriff's Office service location in the Agreement, located at 6035 Landing View Road; and,

WHEREAS, pursuant to Article V. ADDITIONAL PURCHASES of the Agreement, the Parties desire to increase the frequency of weekly cleaning services and add the quarterly custodial services to the services being performed at the Fleet Management, Lee County Sheriff's Office location in Section 18. LOCATIONS of the Exhibit A. SCOPE OF WORK and the corresponding pricing for the increased and new services in the Exhibit B. FEE SCHEDULE of the Agreement, effective immediately upon execution of this Amendment by all Parties.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

 The Parties agree that, effective immediately upon full execution of this Amendment by all Parties, Subsection V. Fleet Management, Lee County Sheriff's Office of Section 18. LOCATIONS of the Exhibit A. SCOPE OF WORK of the Agreement shall be superseded by the following:

- c. The Vendor will be given a minimum of 48 hours' notice of any schedule change.

- 2. The Parties agree that the increase in the weekly services and the addition of the quarterly custodial services at the Fleet Management, Lee County Sheriff's Office location will increase the total Agreement cost by \$5,752.36 per full contract year for the remainder of the Agreement.
