SECOND AMENDMENT OF THE DISASTER RECOVERY SERVICES FOR LEE COUNTY AGREEMENT

THIS SECOND AMENDMENT OF THE DISASTER RECOVERY SERVICES FOR LEE COUNTY AGREEMENT is made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Crowder-Gulf Joint Venture, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for disaster recovery services through Solicitation No. RFP220362BJB with Vendor on the 2nd day of October 2022 ("Agreement"); and,

WHEREAS, after the execution of the agreement, it was determined that it would be in the best interests of the County to add concrete removal services for the rights-of-way within Unincorporated Lee County, as deemed necessary by the County to protect the health and safety of the general public, to Category B of the Exhibit B Fee Schedule of the Agreement; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. In order to add the concrete removal services for rights-of-way within Unincorporated Lee County, as deemed necessary by the County to protect the health and safety of the general public, the Parties agree that the following table shall supersede the table in Category B of the Exhibit B Fee Schedule:
