**RE: TERMINATION OF ANNUAL AGREEMENT – RFP220362BJB-
DISASTER RECOVERY SERVICES FOR LEE COUNTY**

Dear Mrs. Ramsay-Naile:

On October 2, 2022, Lee County entered into an Agreement with Crowder-Gulf Joint Venture, Inc. for the purchase of Disaster Recovery Services for Lee County, on an as needed basis through Solicitation No. RFP220362BJB. On August 18, 2026, Lee County's Board of County Commissioners awarded a new Agreement for the purchase of Disaster Recovery Services for Lee County to Crowder-Gulf Joint Venture, Inc., and other vendors, through Solicitation RFP260035BJB, that was effective immediately.

As a result, pursuant to Section XII. Termination, of the Agreement for Disaster Recovery Services for Lee County, the County is exercising its right to terminate the prior Agreement, through Solicitation No. RFP220362BJB, for convenience. In compliance with the termination procedures established by Section XII, the Agreement shall terminate as of September 19, 2026. Commencing upon the date of receipt of this Notice, the County is mandating a suspension of any remaining work under the prior Agreement and all future work shall be performed under the new Agreement, through Solicitation No. RFP260035BJB.
