 Approve Amendment for Custodial Services for Central Lee County

I. MOTION REQUESTED

- A. Approve Amendment No. 4 to the contract with American Facility Services, Inc., under Solicitation No. RFP220486SML, Custodial Services for Central Lee County, to add custodial services for the new Lehigh Acres Transfer Center service location. The amendment will increase the contract amount by \$26,464.00 annually.
- B. Approve Amendment No. 4 to the contract with United States Service Industries, Inc., under Solicitation No. RFP220486SML, Custodial Services for Central Lee County, to increase the custodial services being provided for the Emergency Operations Center service location. The amendment will increase the contract amount by \$49,147.80 annually.
- C. Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves contract amendments with both American Facility Services, Inc. and United States Service Industries, Inc., under the solicitation for Custodial Services for Central Lee County, to add custodial services for the new Lehigh Acres Transfer Center service location and increase the custodial services being provided for the Emergency Operations Center service location respectively. The amendments will increase the contract amounts by a total of \$75,611.80 annually, with total anticipated expenditures in the amount of \$622,200.34. Total expenditures during Fiscal Year 2023-2024 were \$546,588.54.

III. BACKGROUND AND IMPLICATIONS OF ACTION

On March 21, 2023, the Board of County Commissioners awarded RFP220486SML, Custodial Services for Central Lee County, to American Facility Services, Inc., At Your Service Cleaning Group, Inc., and United States Service Industries, Inc. to provide custodial services in the Central Zone of Lee County, on an as needed basis. The original term of the contract was for three years with an option to renew for up to an additional three years.

On April 18, 2023, Amendment 1 to the contract with American Facility Services, Inc. was approved by the Board of County Commissioners to add two additional custodial service locations, the Fleet Management Satellite Shop and the Solid Waste, Waste to Energy Plant to the contract with American Facility Services, Inc.

On May 16, 2023, Amendment 2 to the contract with American Facility Services, Inc. was approved by the Board of County Commissioners to award two additional custodial service locations, the LeeTran South Transfer Station and the Elevation Warehouse, to the contract with American Facility Services, Inc.

On September 19, 2023, Amendment 3 to the contract with American Facility Services, Inc. was approved by the Board of County Commissioners to add additional custodial service locations within the Solid Waste, Waste to Energy Plant location to the contract with American Facility Services, Inc.

On November 17, 2023, Amendment 1 to the agreement with United States Service Industries, Inc. was administratively approved to remove the quarterly and semiannual cleaning services from the Fleet Management service location.

On January 16, 2024, Amendment No. 2 to the agreement with United States Service Industries, Inc. was approved by the Board of County Commissioners to add custodial services for the East Lee County Government Center to the contract with United States Service Industries, Inc.

On December 3, 2024, Amendment No. 3 to the agreement with United States Service Industries, Inc. was approved by the Board of County Commissioners to increase the price for the purchase of custodial services from United

States Service Industries, Inc. for Central Lee County.
