On March 29, 2023, Lee County entered into an Agreement with At Your Service Cleaning Group, Inc. for custodial cleaning services for central Lee Count, specifically for the Solid Waste, Waste to Energy Plant and the Fleet Management Satellite Shop. On March 31, 2023, At Your Service Cleaning Group, Inc. advised Lee County that they would not be able to provide services under the Agreement, as planned, which were to begin on April 1, 2023.

Pursuant to Section XII. Termination, of the Agreement for Custodial Services for Central Lee County, the County is exercising its right to terminate the Agreement for cause. In compliance with the termination procedures established by Section XII, the Agreement shall terminate effective immediately.
