WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties desire to remove the quarterly and semiannual cleaning services from the Fleet Management service location, in Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK, and from the Exhibit B, FEE SCHEDULE of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that effective upon full execution of this Amendment, Subsection B. FLEET MANAGEMENT of Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK of the Agreement shall be superseded by the following:
