## SECOND AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR LEE COUNTY CENTRAL ZONE

THIS SECOND AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES FOR LEE COUNTY CENTRAL ZONE, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") United States Service Industries, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for Central Lee County through Solicitation No. RFP220486SML with Vendor on the 28<sup>th</sup> day of March, 2023 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interest of the County to add an additional custodial service location, the East Lee County Government Center located at 600 Homestead Road South, Lehigh Acres, Florida to the Agreement; and,

WHEREAS, pursuant to Article V. ADDITIONAL PURCHASES of the Agreement, the Parties desire to add the new service location and scope of work for the East Lee County Government Center, to Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK, and to the Exhibit B, FEE SCHEDULE of the Agreement, effective upon execution of the parties.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective upon full execution of this amendment, Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK of the Agreement shall be supplemented by the following:

## Scheduling

- a. The County, working with the Vendor, may designate the time during which selected areas shall be cleaned.
- b. Cleaning shall be performed on a five day per week basis, exclusive of holidays. Crew scheduling is the Vendor's responsibility and should be arranged so as not to interfere with day-to-day business operations.
- c. Day and evening cleaning crews will be required at this location. The Vendor will be given a minimum of 48 hours' notice of any schedule change.
- d. Day crew shall be required from 7:00 a.m. to 5:00 p.m., and night crew required from 5:00 p.m. until finished. However, these hours may be adjusted depending upon the specific needs of the occupants.
- e. Public restrooms shall be cleaned twice daily. Once at approximately 2:30 p.m. and then at night after normal business hours.
- f. These rooms are not to be entered or cleaned without accompaniment by a County representative:
  - a. Tax Collector IT Network Room
  - b. Tax Collector Office B
- g. Service Identifiers to be performed at this location as listed above:
  - a. Daily Services
  - b. Weekly Services
  - c. Monthly Services
  - d. Quarterly Services
  - e. Semiannual Services

- 2. The Parties agree that custodial services shall begin at the East Lee County Government Complex for Suite 7 Shared Restrooms, Suite 8 & 9 Supervisor of Elections, and Suite 15 Florida Department of Health upon full execution of this amendment.
- 3. The Parties agree that custodial services shall begin at the East Lee County Government Complex for Suites 1 through 6 For the Tax Collector, upon direction from Lee County's Facilities Department to the Vendor.
- 4. The Parties agree that, effective upon full execution of this amendment, the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
